Prayers.

Mr. Horsman gave Notice of Motion 57 that on Thursday, June 6, 2019, he would move the following resolution, seconded by Mr. Harvey:

THAT an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House all documentation since April 15, 2016, including correspondence, however recorded, stored or archived, by electronic means or otherwise, between the Department of Public Safety, the Premier's Office, the Executive Council Office, the Department of Justice and Office of the Attorney General and any other government departments or Crown corporations and federal government departments and agencies with respect to the success of the Contraband Enforcement Unit including, but not limited to, the number of seizures of illegal contraband, the total value of all contraband seized, the value of foregone tax revenue from the sale of an amount of legal goods equivalent to the amount of the seized contraband goods.

Mr. Horsman gave Notice of Motion 58 that on Thursday, June 6, 2019, he would move the following resolution, seconded by Mr. Harvey:

THAT an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House all documentation since November 9, 2018, including correspondence, however recorded, stored or archived, by electronic means or otherwise, between the Department of Public Safety, the Premier's Office, the Executive Council Office, and any other government departments or Crown corporations and federal government departments and agencies with respect to the decision to eliminate the Contraband Enforcement Unit.

Mr. Arseneault, Opposition House Leader, gave notice that on Thursday, May 30, 2019, Opposition Members' Business would be considered in the following order: Motion 36, 8 and 47.

Mr. Savoie, Government House Leader, announced that following third reading, it was the intention of government that the House resolve itself into a Committee of the Whole to consider Bills 27, 22 and 26.

The following Bill was read a third time:

Bill 20, *Statute Law Amendment Act 2019*.

Ordered that the said Bill does pass.

The House resolved itself into a Committee of the Whole with Mr. C. Chiasson in the chair.

At 11.20 a.m. the Committee recessed. At 1.05 p.m. the Committee resumed with Ms. LeBlanc in the chair.

At 3 p.m. the Committee recessed. At 3.28 p.m. the Committee resumed.

And after some time, during consideration of Bill 27, *An Act Respecting Addressing Recommendations in the Report of the Task Force on WorkSafeNB*, Mr. Arseneau moved an amendment to paragraph 6(1)(b).

And the question being put, a debate ensued.
