The period of activities of the Centre communautaire Sainte-Anne (CCSA), from April 1st, 2019, to March 30, 2020, was marked by some great successes but culminated in a pandemic that significantly affected operations.

Over the past year, the Sainte-Anne Community Board has been reflecting on the CCSA's 2017-2022 strategic plan. What point have we reached? What goals have been met? Where do we need to make an extra effort? The aim is to get the community, including accredited organizations and partners of the CCSA, involved in this major update of our strategic plan. Unfortunately, discussions were postponed until the fall of 2020 because of the pandemic.

In September 2019, a new Francophone liaison officer for newcomers joined the staff of the CCSA. The purpose of this new, part-time position is to support newcomer parents and to work more closely with the Multicultural Association of Fredericton to improve some of its services. This position is directly aligned with one of the development focus areas in the CCSA's 2017-2022 strategic plan.

I invite you to browse through this annual report in which we provide an overview of the main activities and achievements of the CCSA and some of its accredited organizations in 2019-2020.

Unfortunately, in March 2020, COVID-19 completely paralyzed the entire planet. On March 17, the CCSA had to close its doors and cease operations indefinitely. Of course, over the coming year, the CCSA and its organizations and partners will have to deal with many challenges and will need to adapt to this harsh reality we all face. I am confident we will be able to reinvent ourselves and continue to offer activities and initiatives to our wonderful community.

COVID-19

On March 17, 2020, the Centre communautaire Sainte-Anne (CCSA) had to cease operations and close its doors indefinitely because of the COVID-19 pandemic.

The following CCSA activities, which were to have taken place prior to March 31, 2020, were cancelled or postponed:

- Rencont'ART with Marcel Boudreau CANCELLED
- FRAGILE exhibit by Carole Bherer CANCELLED
- Performance by Sandra Le Couteur CANCELLED
- Comedy show with Réal Béland POSTPONED

All activities of the CCSA's accredited organizations that were scheduled to take place in the run-up to March 31, 2020, were cancelled as well.

Over the coming year, COVID-19 will have a significant impact on the cultural and artistic events of the Francophone community served by the CCSA. The CCSA and its accredited organizations and partners will have to be patient and show originality in order to reinvent themselves and continue to present activities in French to the Francophone and Francophile community in the capital region.

The CCSA's 2020-2021 annual report will take stock of all this and more.

MANDAT

The Centre communautaire Sainte-Anne (CCSA) is a Crown Corporation responsible for the administration, on behalf of the Government of New Brunswick, of a community centre serving primarily the Francophone community in the Fredericton area. It is administered by the Sainte-Anne Community Board. The Centre communautaire Sainte-Anne Act received royal assent on June 16, 1977. It was proclaimed and came into effect on June 22, 1977, and was consolidated to June 30, 1997.

To contribute, as a unifier, to the promotion and expansion of the Francophone community in the capital city region.

SAINTE-ANNE COMMUNITY BOARD

The Sainte-Anne Community Board is composed of volunteers elected by the community and appointed by the Lieutenant-Governor in Council or by the Minister responsible for the CCSA as well as two representatives from the school sector. The number of members provided for, in the *Centre communautaire Sainte-Anne Act*, is 11.

The Community Board elects its members after the appointments are made by the Premier or the Minister responsible for the CCSA. The Community Board holds a minimum of six public meetings per year.

Three standing committees report to the Sainte-Anne Community Board:

- Strategic committee
- Governance and human resources committee
- Finance and audit committee.



The CCSA team comprises approximately 15 full-time employees and a few part-time front desk attendants who provide customer service in the evenings and on weekends.

In April 2019, Myriam Russell was hired as the new Food and Youth services manager. In September 2019, Marc-Alexandre Lagacy joined the CCSA team as the new Francophone liaison officer for newcomers (part-time position). In November 2019, Marie-Hélène Demers became the new administrative assistant for the CCSA reception desk. In January 2020, Lyne Paquet was hired as the CCSA's financial and administrative services manager. She is temporarily replacing Sylvette Drisdelle, who used to hold this position.

SERVICES OFFERED AT THE CENTRE COMMUNAUTAIRE SAINTE-ANNE

Pursuant to subsection 3(2) of the *Centre communautaire Sainte-Anne Act*, the objects of the Corporation shall be:

- (a) to provide, on land and in buildings and structures referred to in subsection 6(3) (i) educational facilities to allow the School Board to offer instruction of the regular school curriculum in the French language in accordance with the Schools Act, and (ii) community facilities operated by the Board;
- (b) to plan, develop, administer and coordinate the overall community development of the French linguistic community within the boundaries of the geographical area designated under the Schools Act in respect of école Sainte-Anne;
- (c) to facilitate the organizing of primarily Frenchlanguage cultural presentations and other community activities primarily in French by offering development, promotional, technical, support and other similar services;
- (d) to provide facilities for the purposes of carrying out the objects referred to in paragraphs (b) and (c).

The CCSA occupies an area of approximately 25,000 square metres at 715 Priestman Street in Fredericton.

The CCSA programming team, Anna-Lee Vienneau and Murielle Savoie, with the support of the other members of the CCSA team and the many partners and accredited organizations of the CCSA, planned dozens of activities and initiatives in various fields for Fredericton's Francophone community: special events, social gatherings, fundraisers, workshops, talks, courses, excursions, health and wellness activities, etc. Nearly 2,200 people attended the CCSA's community activities in 2019-2020. The CCSA's programming and development branch can rely on the support of the community and public interest advisory committee, composed of one member of the Saint-Anne Community Board and engaged residents and volunteers from the capital region.



CCSA SCHOLARSHIP

Each year, the CCSA gives a \$1,000 scholarship to a student from ÉSA who shows outstanding academic excellence and strong community involvement. The 2019 scholarship was awarded to Cassidy Lafrance, who plans to pursue her post-secondary studies in business administration at the Université de Moncton.





Y'A PAS JUSTE À NOËL QU'ON A FAIM! FOOD DRIVE

April 11, 2019 – This annual drive, held in the CCSA parking lot, brought in 22 boxes of non-perishable food items (approximate value of \$1,100) and about \$575 for the Fredericton Food Bank.

OUTDOOR FAMILY DAY

May 25, 2019 – Outdoor family day, held at Odell Park, was organized and offered free of charge by the Réseau franco mieux-être de la Capitale in cooperation with the CCSA. Many intergenerational activities focusing on wellness were on offer: children's booths (face painting, bubbles, circus, reading tent); yoga, Zumba, rhythmic dance, and tai-chi demonstrations; nature walk and frisbee golf; etc.

CONTEST: COME UP WITH A NAME FOR THE CCSA'S OUTER ROOM

May 2019 – A contest was launched to find a name for the CCSA's outer room. This space was added to the building after the work to expand the CCSA was completed in 2008. This superb 126-m2 (1,367 sq. ft) community hall is located next to the Noreen-Richard Health Centre.

The winning name, Salle Beausoleil, was suggested by Monique Sénéchal, who won several prizes: a pair of tickets to a show of her choice presented by the CCSA during the 2019-2020 season, a \$50 gift card from Café d'ici, and a \$150 gift card from the Regent Mall. The new name was unveiled on June 10 during some activities to mark the CCSA's 41st anniversary (details on the next page).

CCSA 41th ANNIVERSARY CELEBRATIONS

June 10, 2019 – To celebrate its 41st anniversary, the CCSA hosted a BBQ, which was attended by around 120 people.

The new name of the CCSA's outer room was unveiled during the event, following a naming contest that was launched in May. The winner was Monique Sénéchal, who suggested the name "Salle Beausoleil" (details on previous page).

An exhibit of fences was held, as well, following a family activity – Paint your family portrait on a fence! – sponsored by the CCSA, which invited families to paint each of their family members on a wooden board, under the direction of painter Marcel Boudreau.

SAINT-JEAN-BAPTISTE CELEBRATIONS IN OROMOCTO

June 22, 2019 – The celebrations took place with the group Deuxième frette at Griffins Pub and Eatery, where poutine was on the menu for the occasion. This activity was hosted by the CCSA, in cooperation with the Gagetown Military Family Resource Centre.

NATIONAL ACADIAN DAY

August 15, 2019 – Nearly 500 people took part in the usual activities: Mass of the Assumption at the Sainte-Anne-des-Pays-Bas church, games for children and a BBQ (Officers' Square), Acadian flag-raising ceremony, and the tintamarre. For the second year in a row, Acadian cuisine was served and a cash bar was available. There was also a contest to win four lobsters from Peter's Meat Market.

Ave Maris Stella was performed by La voix des deux rives, a group made up of members of Choeur de Soulanges and students from École de musique communautaire Marie-Sol. There were two outdoor shows: Sébastien Boudreau and Robert Duguay, in the afternoon, and Danny Party, who closed out the day.

The official partners were the Knights of Columbus (Council 8409), the Maison des jeunes L'acAdo, the City of Fredericton, école Sainte-Anne, Peter's Meat Market, the Historic Garrison District of Fredericton, and Picaroons Traditional Ales.

CERTIFICATE OF RECOGNITION AWARDED TO THE CCSA BY THE CRC

October 2019 – The Canadian Red Cross (CRC) awarded a certificate to the CCSA in recognition of the assistance it provided during the flooding in the spring of 2019 in the Fredericton area. A special fundraiser was held on April 30, which brought in \$601.35 and many non-perishable food items, which were donated to the CRC.

November 5, 2019 – Around 25 people attended this get-together, during which there were a number of interesting exchanges between newcomers and stakeholders from the local Francophone community. The 5 à 7 was held at CCSA's Galerie des Bâtisseurs, and a light snack was served.

CHRISTMAS MARKET

December 7, 2019 – For this fifth edition of the Christmas market, held by the CCSA in cooperation with several organizations and partners, some 40 booths were set up at the entrance to the CCSA and in the Galerie des Bâtisseurs. For the second time, the market was held on the same day at the Santa Claus breakfast at École des Bâtisseurs, during which a number of activities were held, including a breakfast served by the Knights of Columbus (Council 8409), Christmas crafts and colouring, and a silent auction with prizes and themed baskets.

December 10, 2019 – Organized by the CCSA, École des Bâtisseurs, École Les Éclaireurs, Service de garde L'Envolée, Au p'tit monde de franco daycare centre, Sainte-Anne-des-Pays-Bas church, Knights of Columbus (Council 8409), CJPN, and CÉ D'ICI, this annual food drive, held at the CCSA and École Les Éclaireurs, brought in \$850 and many bags of non-perishable food items. The donations were given to the Knights of Columbus (Council 8409) for their Christmas baskets and to the Fredericton Food Bank.

SURVEY ON COMMUNITY AND CULTURAL DEVELOPMENT AND COMMUNITY ENGAGEMENT

March 2020 – To achieve some of the goals in its 2017-2022 strategic plan, the CCSA conducted a survey to define cultural and community development and community engagement.

The participants were asked the following three questions:

QUESTION 1 – In a few words, define community development. QUESTION 2 – In a few words, define cultural development. QUESTION 3 – What does community engagement mean?

The many responses received will enable the CCSA to come up with some strategic definitions over the coming months.

COURSES AND WORKSHOPS OFFERED IN FRENCH AT THE CCSA

• Physical fitness programs: Strong by Zumba, Pound Fitness, and Zumba April 2 to May 9, 2019 / September 15, 2019 to March 30, 2020

Each course offered once a week, for a total of three sessions per week. Led by Julie Cormier, certified instructor.

Sponsored by the CCSA and offered in French by Sushi World Restaurant.

• Collective kitchen – April 28, 2019

Intergenerational culinary activity offered with the collaboration of CODAC NB and Noreen-Richard Health Centre.

- Woodworking courses October 27 and November 3, 2019 A two-part introductory woodworking course was given by Marc-André Godin at the CCSA.
- Babysitting course November 16, 2019

Offered by the St. John Ambulance at the CCSA and presented by the Maison des jeunes L'acAdo.

CUSTOMER AND MAINTENANCE SERVICES

The team is made up of Sara Laflamme, Customer Service Director; Marie-Hélène Demers, Administrative Assistant-Reception; front desk attendants; the maintenance and infrastructure staff (Gilles Losier, supervisor, Nicolas Augereau and Yves Pelletier, attendants); and the janitorial team (services provided by the Sprucegrove Building Cleaners company).

Customer service begins with the front desk attendants at the CCSA reception, by phone or in person. The CCSA offers a range of services to its clients, tenants and accredited organizations such as photocopying, fax, sorting and distribution of mail; distribution of various information material (*L'Info-lien*, folders, posters, etc.); registration in courses for adults and young people, management of ticketing for shows and events of external clients, room reservations for conferences, meetings, courses, weddings and equipment rental.

Most of the CCSA's income is from room rentals for its services offered: schools, daycare, CJPN, Café d'ici, Noreen Richard Health Centre, Centre d'appui, and Mosaïque Centre. It also comes from the room rental service (Bernard Poirier Theatre, gymnasiums, cafeterias, numerous rooms for meetings, conferences, workshops and courses).

Insofar as they are able, the maintenance staff carry out various repairs and installations in the CCSA building.

The janitorial team looks after the building's maintenance and cleaning and is responsible for preparing rooms for meetings and other activities.



Under François Albert, Director of Communications, and Anny Martel, Communications Officer, this service is mainly responsible for promoting the activities, events, and shows presented by the CCSA, its member organizations, and tenants, and to ensure the CCSA projects a professional and uniform image.

The CCSA uses several effective communication tools to keep the community informed about activities and the progress of certain issues, in particular:

- The monthly newsletter, L'Info-lien, is free of charge; 2,000 copies are distributed (each month) from September to June, in the region's Francophone schools, certain businesses, certain provincial and federal departments, and at the Camp Gagetown military base. L'Info-lien is also available in the display unit at the CCSA and on its website.
- A weekly chronicle, *Dites-le à vos amis...*, is e-mailed to over 1,700 people every Thursday.
- The CCSA updates on a regular basis its website (www.centre-sainte-anne.nb.ca), its Facebook page (Centre.communautaire.Sainte.Anne) and Twitter account (@CCSAFred).
- An information kit describing the main services and activities offered at the CCSA is available for newcomers.
- 2,000 copies of a program booklet detailing the CCSA's 2019-2020 season activities (September to August) were distributed throughout the region.
- A dozen screens are set up at the CCSA in high-traffic areas, displaying a scrolling list of coming activities in French.

New website

In November 2019, the CCSA communications team has started research to create a new website.

It should be launched in the fall of 2020.



INDEPENDENT AUDITOR'S REPORT

To the Board of Directors of Centre communautaire Sainte-Anne

Opinion

We have audited the financial statements of Centre communautaire Sainte-Anne "the Centre", which comprise the statement of financial position as at March 31, 2020, statements of operations, changes in net assets and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Centre as at March 31, 2020, and the results of its operations and its cash flows for the year then ended in accordance with Canadian public sector accounting standards.

Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. In preparing the financial statements, management is responsible for assessing the Centre's ability to continue as a going concern, disclosing, as applicable, matters relating to going concern and using the going concern basis of accounting unless management either intends to liquidate the Centre or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Centre's financial reporting process.

1. Nature of activities

The Centre communautaire Sainte-Anne (the "Centre") is a charitable non-profit Crown corporation pursuant to the *Le Centre communautaire Sainte-Anne Act* assented to on June 16, 1977. The main objective of the Centre is to promote and facilitate the establishment of French language cultural activities and services for the Francophone community in the greater Fredericton area.

2. Summary of significant accounting policies

These financial statements have been prepared by management in accordance with Canadian public sector accounting standards. The Centre applies the standards for not-for-profit organizations in the Canadian Professional Accountants (CPA) public sector accounting standards (PSAS) handbook. A summary of significant accounting policies is presented in the following paragraphs :

a) Expenditures assumed by the Province of New Brunswick

The construction costs of the building used by the Centre and a portion of the costs of repairs and improvements to the property have been paid by the Province of New Brunswick, the owner. These transactions are not reflected in the financial statements of the Centre.

b) Capital assets

Capital assets are recorded at cost. The Centre has adopted the policy of expensing capital assets acquired with an individual value of \$ 5,000 or less. Disposals of capital assets are removed from the accounts at their net book value. Repairs and maintenance are charged to operating expense. Betterments, which extend the estimated life of the asset owned by the Centre (i.e. which increases its service capacity or reduces future costs), are capitalized. Amortization is taken on capital assets on a straight line basic over the estimated useful life of the assets, at the following annual rates:

Improvements to buildings	10 years
Equipment and furniture	10 years
Computer equipment	5 years
Vehicles	5 years

c) Revenue recognition

The Centre follows the deferral method of accounting for contributions, which consist of project financing and governmental grants.

The Centre records operating grants as revenue in the period to which they relate.

Contributions restricted to the purchase of capital assets are deferred and amortized at the same rate as their respective capital asset. Non-restricted contributions are recorded as revenue in the period in which they are earned if the amount receivable can be reasonably estimated and collectability is reasonably assured.

Deferred revenue includes grants received before year end but not yet earned.

2. Summary of significant accounting policies (continued)

d) Measurement uncertainty

The preparation of financial statements requires management to make estimates and assumptions that affect the amounts of assets and liabilities reported and the presentation of contingent assets and liabilities at the date of the financial statements, and the amounts of revenues and expenses reported during the period. Significant areas where estimates are made are value of accounts receivable, employee benefits, and the estimated useful life of capital assets. Actual results could differ from management's best estimates, as additional information becomes available in the future.

e) Inventory

Inventory is valued at the lower cost and net realizable value. Net realizable value is the estimated selling price in the ordinary course of business, less any applicable costs associated with its sale or disposal.

f) Cash

Cash is an amount of money readily available, in a financial institution or in another monetary account.

g) Accumulated sick leave benefits

Employees of the Centre are entitled to sick leave benefits which accumulate but do not vest. Management has calculated the amount of the sick leave benefit liability and has determined that the amount is not significant; therefore a liability has not been recorded in these financial statements.

h) Pension expenses paid by the Province of New Brunswick

Full-time employees of the Centre are entitled to receive pension benefits under the New Brunswick Public Service Superannuation Plan. Effective January 1, 2014 the Province converted this plan to the Public Service Share Risk Plan. This converted plan requires all employer classified full-time employees to participate in this new plan. The plan continues to be a multi-employer plan under which contributions are made by both the employee and employer. The Centre is limited to its annual contributions which were \$ 83,294 for the year (\$ 86,951 in 2019)

i) Expense recognition

The Centre uses the accrual basic of accounting for expenses. Amounts paid or payable are recognized as expenses in the period in which the goods are delivered or the services provided to the Centre. Amounts paid in advance are reported as Prepaid expenses.

3. Budget

The budget figures, as shown in the statement of operations, have been approved by the Board of Directors of the Centre.

8. Financial instruments

Financial instruments consist of cash, accounts receivable, accounts payable and accrued liabilities. Carrying value is assumed to approximate fair value because of their short term maturity.

Unless otherwise stated, management is of the opinion that the Centre is not subject to significant risks related otherwise to interest rates and exchange rates stemming from these financial instruments because of their short term maturity.

Credit risk

Credit risk results from the uncertainty of predicting financial difficulties that the organizations may encounter that would render them unable to discharge an obligation to the Centre. The Centre manages this risk by having a diversified list of customers; thereby spreading the exposure over multiple customers. Management is of the opinion that there is no significant credit risk at March 31, 2020.

The maximum exposure to this risk at March 31, 2020, is equal to the accounts receivable balance of \$ 119,842.

Liquidity risk

Liquidity risk is the risk of not being able to settle or meet an obligation on time or at a reasonable price. The Centre receives sufficient funds from the Province and its operational activities in order to settle its obligations when they become due.

9. Related party transactions

In 2019-2020, the Centre received from the government of New Brunswick a grant of \$ 701,629 (\$ 701,629 in 2019), as well as revenue from various departments of \$ 1,371,184 (\$ 1,285,482 in 2019) for a total of \$ 2,072,813 (\$ 1,987,111 in 2019). Of this amount, \$ 0 is receivable as at March 31, 2020.

10. Economic dependence

The Centre communautaire Sainte-Anne is economically dependent of the Province of New Brunswick.

11. Net assets management

The objective of the Centre communautaire Sainte-Anne in relation to net assets management is to remain a viable entity while fulfilling its mandate, which is to contribute, through its unifying role, to the recognition and the promotion of francophone communities in the capital region. It achieves this objective through strong daily management of cash flows and the regular comparison of revenues and expenses to the annual operational and capital budgets.

12. Significant Event

During the year, on March 11, 2020, the World Health Organization characterized the outbreak of a strain of the novel coronavirus ("COVID-19") as a pandemic which has resulted in a series of public health and emergency measures that have been put in place to combat the spread of the virus. The duration and impact of COVID-19 is unknown at this time and it is not possible to reliably estimate the impact that the length and severity of these developments will have on the financial assets and condition of the Organization in future periods.
