During Statements by Ministers, Hon. Mr. Byrne rose on a Point of Order, his point being that a Member speaking in response to a Minister's statement must confine his remarks to the contents of the statement.

Mr. Speaker, having heard several Members on the point of order, stated that Members should follow Standing Rules 40(1) and 40(2) which adequately set out the rules governing statements by Ministers.

During Statements by Members, Mr. Mockler rose on a Point of Order, his point being that statements should be limited to 60 seconds as mandated by the rules.

Mr. Speaker stated that he has allowed latitude to all Members in applying the time limits and would continue to use common sense and discretion in this regard.

Hon. Mr. Richard rose to correct certain press statements attributed to him.

Mr. Speaker stated that the matter did not involve a question of privilege but noted that when Members are quoted, the appropriate documents should be made available to the Members of the House.

Bill 3, An Act to Amend the Saint John Regional Exhibition Centre Commission Act.

Bill 4 An Act to Amend the Saint John Aquatic Center Commission Act. Ordered referred to the Standing Committee on Private Bills. **Notices of Motions** Hon, Mr. Blanchard gave Notice of Motion 59 that on Tuesday, December 8, 1998, he would move the following resolution, seconded by Hon. Mr. C. Thériault: THAT this House approves in general the budgetary policy of the government. **Government Motions re Business of House** On motion of Hon. Mr. Byrne, seconded by Hon. Mr. C. Thériault, RESOLVED, that when the House adjourns on Thursday, December 3rd, it stand adjourned until Friday, December 4th at 11 o'clock a.m. Hon. Mr. Byrne announced that following second reading of Bill 2, it was the intention of the government that the House resume debate on the motion for an Address in Reply to the Speech from the Throne. **Notices of Motions** After requesting Mr. Speaker revert to the Order of Notices of Motions, Mr. Lord gave Notice of Motion 60 that on Thursday, December 10, 1998 he would move the following resolution, seconded by Mr. Robichaud: That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House financial assistance granted to motels, hotels, and accommodation centres in the Acadian Peninsula over the past ten (10) years. Mr. Mockler gave Notice of Motion 61 that on Thursday, December 10, 1998 he would move the following resolution, seconded by Mr. D. Graham:

That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House a list, by region, by date and by financial amount, of all government loans, grants, guarantees, given to companies, agencies, industries or corporations, by any government department or agency after which the company, agency, industry or corporation has, at any time in the past ten years, either gone bankrupt or has defaulted on its loan payment.

## **Second Reading**

The Order being read for second reading of Bill 2, *An Act to Amend the Family Services Act*, a debate arose thereon.

After some time, Hon. Mr. Byrne rose on a Point of Order, his point being that debate at the second reading stage should be limited to the principle of the Bill.

Mr. Speaker having heard members on the point of order, ruled that debate at the second reading stage is limited mainly to the principle of the Bill, but this being vague area, a certain amount of latitude is allowed.

Mr. Speaker further ruled that it is not in order at second reading to discuss clauses of the Bill in detail.

And the debate being ended, and the question being put that Bill 2 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 2, *An Act to Amend the Family Services Act*, was read a second time and ordered referred to the Committee of the Whole House.
