# **Standing Committee on Public Accounts**

Mr. Sherwood, from the Standing Committee on Public Accounts, presented the First Report of the Committee for the session which was read and is as follows:

Mr. Speaker:

Your Standing Committee on Public Accounts begs leave to submit this its First Report for the Fourth Session of the Fifty-third Legislative Assembly.

This report outlines the Committee's work during the year 1998.

The Committee met on January 6, 1998, in a joint session with the Standing Committee on Crown Corporations. The purpose of the meeting was to receive and review the 1997 Report of the Auditor General of New Brunswick. Auditor General, Daryl Wilson, briefed the Committees on the contents of the Report and answered questions posed by Committee members.

The Committee met on February 5 and 25, 1998, to consider an agenda and set dates for future hearings.

On May 6, 1998, the Committee met in a working session, to review the Annual Report of the Auditor General and prepare for committee hearings. The Auditor General highlighted several issues of importance for the Committee to consider, including year 2000 readiness, performance indicators and timeliness of financial information. The Auditor General outlined strategic plan highlights for his Office, including its goal to broaden the support it provides to the Legislative Assembly.

**Special Reports** 

At the Meeting of the Standing Committee on Public Accounts held on April 1, 1997, the following two motions were adopted by the Committee:

- 1. That the Auditor General undertake to review the financial terms of the Evergreen and Wackenhut leases and compare the total cost under the private sector arrangements as compared to traditional government methods.
- 2. That the Auditor General inquire whether economic development activities in the Minto area which are funded by N.B. Power are in accordance with the legislative authority granted to N.B. Power under the <u>Electric Power Act</u>.

The Auditor General advised that his Office would carry out the assignments and report back to the Committee with its findings.

Accordingly, on November 17, 1998, the Auditor General submitted two reports prepared as a result of the assignments from the Committee. A copy of the covering letter from Daryl C. Wilson, Auditor General, is attached hereto as Appendix "A". A copy of the Report on the *Evergreen and Wackenhut Leases* is attached hereto as Appendix "B". A copy of the Report on *NB Power Funding of Minto Economic Development Activities* is attached hereto as Appendix "C".

On November 19, 1998, the Committee met with the Auditor General to review the reports. The Auditor General outlined the work undertaken by his office to complete the projects and presented the highlights and findings of both reports.

The Committee subsequently received a letter from the Auditor General, dated November 27, 1998, correcting certain information and explanations given during his appearance on November 19. A copy of this letter is attached hereto as Appendix "D".

## Election of Chairman

The Committee met on December 15, 1998. On Motion of Mr. Flynn, Mr. Sherwood was elected Chairman.

## 1998 Report of the Auditor General

On December 15, 1998, the Committee met in a joint session with the Standing Committee on Crown Corporations, to receive and review the *1998 Report of the Auditor General of New Brunswick*.
