Mr. Speaker delivered the following Statement:

STATEMENT

Honourable Members:

Prior to adjourning on December 20, 2000, the House adopted the following motion:

RESOLVED, that when the Assembly adjourns at the end of this sitting day, it stand adjourned until Tuesday, March 27, 2001, provided always that if it appears to the satisfaction of Mr. Speaker, after consultation with the Government, that the public interest requires that the House should meet at an earlier time during the adjournment, Mr. Speaker may give notice that he is so satisfied and in such notice shall state a time at which the House shall meet, and thereupon the House shall meet at the time so stated and shall transact its business as if it has been duly adjourned to that time.

Yesterday, I was informed by the Honourable the Premier, on behalf of the government, that the province's hospital workers had entered into a legal strike position and that strike action had begun.

The Premier advised that strike action by hospital support workers would have an immediate and serious effect on the ability of provincial hospitals to deliver important health services to the citizens of New Brunswick, and that a walkout of any duration would stand to cause severe and undue disruption within the province's health care system.

The Premier requested that I consider recalling the House immediately to consider back-to-work legislation.

Accordingly, being satisfied that the public interest did so warrant, and in accordance with the terms of the resolution adopted December 20, 2000, Notice was issued by me yesterday, calling the House into session on Saturday, March 3rd, 2001 at the hour of 3 o'clock in the afternoon.

I am tabling the letter from the Premier, dated March 2, 2001, and the Notice issued by me, dated March 2, 2001.

Hon. Mr. Harrison laid upon the table of the House the following documents:

Letter from Hon. Bernard Lord, Premier, dated March 2, 2001, requesting that the Speaker, Hon. Bev Harrison, recall the House to Saturday, March 3, 2001.

Notice of Hon. Bev Harrison, Speaker, to all Members that it is in the public interest that the House meet at an earlier time during the adjournment and that the Legislative Assembly of New Brunswick shall meet on Saturday, March 3, 2001, at the hour of 3 o'clock in the afternoon to transact business.

Hon. Mr. Harrison, pursuant to the provisions of the *Elections Act*, laid upon the table of the House the returns of votes polled in the electoral districts of Campbellton and Caraquet in the by-election held February?5, 2001.

Mr. Jean Dubé, member-elect for the electoral district of Campbellton, and Mr. Gaston Moore, memberelect for the electoral district of Caraquet, having previously taken the oath and signed the Roll, were introduced by the Honourable the Premier and took their seats in the House.

THAT there shall be three hours allocated to consideration of the motion for third reading of the said Bill, and at the expiration of three hours, unless sooner concluded, the Speaker shall interrupt the proceedings and put every question necessary to dispose of the order for third reading of the Bill; and, THAT notwithstanding Standing Rule 44(1), consideration of the Bill, pursuant to this motion, be a Special Order of the Assembly to be called immediately after Orders of the Day.

That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House from the Office of the Premier, the Minister of Finance, or the Minister of Health, copies of all correspondence, including electronic, memos, reports, or any other document relating to the contract negotiations between the Government of New Brunswick and the province's hospital workers for the period February 2nd to March 2nd, 2001.
