Pursuant to Standing Rule 10, Mr. Richard rose on a point of privilege to complain to the House regarding a statement made by Hon. Mrs. Blaney, the Minister of Public Service, during a CBC radio broadcast aired on April 23, 2002. Mr. Richard submitted that the remarks referred to him personally and were incorrect and misleading.

Mr. Williams, from the Select Committee on Local Governance and Regional Collaboration , presented the Second report of the Committee, which was read and is as follows:

April 23, 2002.

To The Honourable The Legislative Assembly of The Province of New Brunswick.

Mr. Speaker:

I have the pleasure to present herewith the Second Report of the Select Committee on Local Governance and Regional Collaboration.

Your Committee was mandated with the responsibility of conducting public consultation with respect to recommendations made in the Report of the Minister's Round Table on Local Governance.

This Report is a progress report of your Committee's work since its last report to the House on January 10, 2002.

Your Committee held thirteen days of public hearings throughout the province during the months of February and March of 2002. Public hearings were held in Dalhousie, Bathurst, Inkerman, Oak Bay, Hampton, Salisbury, Douglastown, Grand Barachois, Bouctouche, Upper Kingsclear, Hartland, and Saint-Joseph-de-Madawaska, with the final public hearing taking place in Fredericton in the Legislature's Council Chamber. The Committee listened to approximately 200 presentations and, to date, a total of 128 written submissions have been received by the Committee.

Your Committee looks forward to preparing its final report and recommendations on local governance and regional collaboration, and submitting it to the House.

On behalf of the Committee, I wish to thank the many presenters who appeared before the Committee at the public hearings and all the individuals and organizations who submitted written briefs. As well, I wish to thank everyone who attended the hearings and took part in this important process.

And your Committee begs leave to make a further report.

And after some further time spent in Committee of Supply, due to the unavoidable absence of Mr. Speaker, Mr. Ashfield, the Deputy Speaker, resumed the chair as Acting Speaker and Mr. Bernard, the Chairman, after requesting that Mr. Deputy Speaker revert to Presentations of Committee Reports, reported that the Committee had had under consideration the matters referred to them, had made some progress therein, had passed several items, and asked leave to sit again.

Pursuant to Standing Rule 78.1, Mr. Deputy Speaker then put the question on the motion deemed to be before the House, that the report be concurred in, and it was resolved in the affirmative.
