Mr. S. Graham gave notice of Motion 90, that on Thursday, February 6, 2003 he would move the following resolution, seconded by Mr. Richard:

That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House all copies of letters, correspondence, e-mails, memos and/or contracts between the Province of New Brunswick with either CIBC World Markets or Salomon Smith and Barney since June 1999.

Hon. Mr. P. Robichaud announced that, following the time reserved for Private Members' Motions, it was the intention of the government that the House resolve itself into a Committee of Supply to take into consideration the estimates of the Department of Public Safety.

It was agreed by unanimous consent to adjourn this day's sitting at 6.00 o'clock p.m.

Debate resumed on Motion 2, moved by Mr. S. Graham, seconded by Mr. Richard, as follows:

WHEREAS an Act introducing nurse practitioners was adopted during the last session of the Legislative Assembly;

WHEREAS the University of New Brunswick only offers a part-time nurse practitioner program;

WHEREAS there is no Francophone nurse practitioner program at the Université de Moncton;

WHEREAS nurse practitioners are in very high demand across the country;

BE IT THEREFORE RESOLVED that the Legislative Assembly urge the New Brunswick government to set up a dedicated fund for a nurse practitioner program at the Université de Moncton and at the University of New Brunswick.

And after some time, due to the unavoidable absence of Mr. Speaker, Mr. Ashfield, the Deputy Speaker, took the chair as Acting Speaker.

And after some further time, Mr. Bernard took the chair.

And after some time, Mr. Speaker resumed the chair.

And after some further time, Mr. Speaker interrupted proceedings and advised that the time allotted for Private Members' Motions had expired.

The House, according to Order, resolved itself into a Committee of Supply with Mr. Ashfield in the chair.

And after some time, Mr. Speaker resumed the chair, and Mr. Ashfield, the Chairman, after requesting that Mr. Speaker revert to Presentations of Committee Reports, reported that the Committee had had under consideration the matters referred to them, had made some progress therein, and asked leave to sit again.

Pursuant to Standing Rule 78.1, Mr. Speaker then put the question on the motion deemed to be before the House, that the report be concurred in, and it was resolved in the affirmative.

And then 6.00 o'clock p.m., the House adjourned.
