Mr. Richard rose on a point of order and requested that remarks made by the Minister of Justice in reference to the absence of the Leader of the Opposition from a committee meeting be withdrawn. The Minister withdrew the remarks, following which the Speaker reminded Members that reference should not be made to the absence of a Member from the House, and, by extension, to a Member's absence from a committee.

Mrs. Mersereau gave Notice of Motion 91 that on Tuesday, February 18, 2003 she would move the following resolution, seconded by Mr. Richard:

That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House all correspondence, e-mails, letters, memos regarding the Athletes' Village in Dalhousie for the 2003 Bathurst/Campellton Canada Winter Games.

Hon. Mr. Green announced that it was the intention of government that following second reading, the House would resolve itself into a Committee of the Whole to consider legislation, in particular, Bill 30.

The Order being read for second reading of Bill 33, *An Act Respecting Gasoline and Diesel Oil Fair Marketing Practices*, a debate arose thereon.
