Prayers.

Hon. Mr. Murphy, Member for Moncton North, laid upon the table of the House a petition signed by citizens of New Brunswick who oppose Bill 17, *An Act to Amend the Off-Road Vehicle Act*. (Petition 18).

Mr. Northrup, Member for Kings East, laid upon the table of the House a petition on behalf of residents of Bald Hill urging the government to properly repair Bald Hill Road in Wards Creek, Kings County. (Petition 19).

Hon. D. Landry laid upon the table of the House a document entitled "New Brunswick Department of Transportation, Fundy Islands Ferry Services Project, Requests for Proposals, Executive Summary."

Hon. Mr. Jamieson, Government House Leader, announced that it was the intention of government that the House resolve itself into a Committee of Supply to consider the estimates of the Department of Environment, Office of Human Resources and the Department of Natural Resources.

The House, according to Order, resolved itself into a Committee of Supply with Mr. R. Boudreau in the chair.

At 12.30 o'clock p.m., the Chairman left the chair to resume again at 2 o'clock p.m.

The Committee resumed with Mr. R. Boudreau in the chair.

And after some time, Mr. Kenny took the chair.

At 4.24 o'clock p.m., the Chairman declared a recess and left the chair.

4.30 o'clock p.m.

The Committee resumed with Mr. Kenny in the chair.

And after some time, it was agreed by unanimous consent to sit past the ordinary time of daily adjournment.

And after some further time, Mr. Speaker resumed the chair and Mr. Kenny, the Chairman, after requesting that Mr. Speaker

revert to Presentations of Committee Reports, reported that the Committee had had under consideration the matters referred to them, had made some progress therein, had passed several items, and asked leave to sit again.

Pursuant to Standing Rule 78.1, Mr. Speaker then put the question on the motion deemed to be before the House, that the report be concurred in, and it was resolved in the affirmative.

The following are the items reported:

Resolved, That there be granted to Her Majesty a sum not exceeding \$5,535,000 to defray the expenses of the following program allocations for the fiscal year ending the 31st of March, 2008:

Less amounts authorized by law.....	39,000
Voted .....	5,535,000

GENERAL GOVERNMENT

Voted, Supply in the following amounts to defray the expenses of the following programs for the fiscal year ending the 31st of March, 2008:

Employee Benefit Plans.....	39,421,000
Equal Employment Opportunity Program .....	483,000
New Brunswick Public Service Internship Program .....	818,000

The said items were concurred in by the House.
