Mr. Steeves, Member for Albert, laid upon the table of the House a petition signed by citizens who oppose Bill 17, An Act to Amend the Off-Road Vehicle Act. (Petition 23)

Hon. Mr. Murphy welcomed to the Chamber Edgar LeGresley, the former Liberal MLA for Northumberland (1970-1974) and Miramichi Bay (1974-1982).

Hon. Mr. Jamieson, Government House Leader, announced that with unanimous consent to dispense with the time reserved for Private Members' Motions, it was the intention of government that the House resolve itself into a Committee of the Whole to resume consideration of Bill 3; following which the House would resolve itself into a Committee of Supply to take into consideration the estimates of the Department of Finance.

It was agreed by unanimous consent to dispense with the Order of Private Members' Motions.

Motion 45 was, by leave of the House, withdrawn.

The House resolved itself into a Committee of the Whole with Mr. R. Boudreau in the chair.

And after some time, Mr. Kenny took the chair.

At 4.43 o'clock p.m. the Chairman declared a recess and left the chair.

The Committee resumed with Mr. Kenny in the chair.

And after some time, Mr. R. Boudreau resumed the chair.

And after some further time, Mr. Speaker resumed the chair and Mr. R. Boudreau, the Chairman, after requesting that Mr. Speaker revert to Presentations of Committee Reports, reported:

That the Committee had directed that he report progress on the following Bill:

Bill 3, *An Act to Amend the Liquor Control Act.*

And the Committee asked leave to make a further report.

Pursuant to Standing Rule 78.1, Mr. Speaker put the question on the motion deemed to be before the House, that the report be concurred in, and it was resolved in the affirmative.

The House according to Order resolved itself into a Committee of Supply with Mr. Kenny in the chair.

At 6 o'clock p.m., the Chairman left the chair to resume again at 7 o'clock p.m.
