Mr. Brewer, the Member for Southwest Miramichi, laid upon the table of the House a petition from residents of the residential camp sites known as "Upper Libby Brook Cluster" urging the government to replace the bridge crossing Libby Brook and to repair the road leading thereto. (Petition 36)

Mr. Kennedy from the Standing Committee on Private Bills presented the second report of the Committee for the session, which was read and is as follows:

Your Committee met on May 10 and 17, 2007, in the Legislative Council Chamber and had under consideration:

Bill 55, *An Act to Authorize an Easement Though Certain Lands in The City of Saint John for Natural Gas Pipeline Purposes,*

and reports that they have made certain progress therein.

And your Committee begs leave to make a further report.

I move, seconded by the Member for Nepisiguit, that the report be concurred in by the House.

Mr. Speaker put the question on the motion of concurrence in the report of the Committee and it was resolved in the affirmative.

Mr. Huntjens gave Notice of Motion 64, that on Thursday, May 24, 2007, he would move the following resolution, seconded by Mr. Alward:

That an address be presented to His Honour the Lieutenant-Governor, praying that he cause to be laid upon the table of the House all applications for special care homes over the last five years in the order they were received by the government and the current status of these applications.

Motions 37, 38, 42, 43, 46, 48, 49 and 51 were, by leave of the House, withdrawn.

It was agreed by unanimous consent to dispense with the two hours reserved for Private Members' Motions.

Hon. Mr. Jamieson, Government House Leader, announced that following third and second reading, it was the intention of the government that the House resolve itself into a Committee of Supply to consider the estimates of the Department of Business New Brunswick and the Department of Health.

The following Bills were read a third time:

Bill 52, *An Act to Amend the Provincial Offences Procedure Act.*

Bill 53, *An Act to Amend the Energy and Utilities Board Act.*

Bill 54, *An Act to Amend the Petroleum Products Pricing Act.*

Bill 61, *An Act to Amend the Support Enforcement Act.*

Bill 62, *An Act to Amend the Securities Act.*

Ordered that the said Bills do pass.

The Order being read for second reading of Bill 65, *Petroleum Act*, a debate arose thereon.

And the debate being ended and the question being put that Bill 65 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 65, *Petroleum Act*, was read a second time and ordered referred to the Committee of the Whole House.

The Order being read for second reading of Bill 66, *An Act to Amend the Pension Benefits Act*, a debate arose thereon.

And the debate being ended and the question being put that Bill 66 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 66, *An Act to Amend the Pension Benefits Act*, was read a second time and ordered referred to the Committee of the Whole House.

The House, according to Order, resolved itself into a Committee of Supply with Mr. Kenny in the chair.

At 6 o'clock p.m., the Chairman left the chair to resume again at 7 o'clock p.m.

The Committee resumed with Mr. R. Boudreau in the chair.

And after some time, Mr. Speaker resumed the chair, and Mr. R. Boudreau, the Chairman, after requesting that Mr. Speaker revert to Presentations of Committee Reports, reported that the Committee had had under consideration the matters referred to them, had made some progress therein, and asked leave to sit again.

Pursuant to Standing Rule 78.1, Mr. Speaker then put the question on the motion deemed to be before the House, that the report be concurred in, and it was resolved in the affirmative.

And then, 10 o'clock p.m., the House adjourned.
