Hon. Mr. Murphy laid upon the table of the House the following documents:

“Advancing health care by putting patients first. Transforming New Brunswick’s Health-care System: The Provincial Health Plan 2008-2012” and “Advancing health care by putting patients first. Transforming New Brunswick’s Health-care System: The Provincial Health Plan 2008-2012 Major Initiatives.”

Hon. Mr. Murphy, Government House Leader, announced that it was the intention of government that the House resume the adjourned debate on the budget; following which the House would resume the adjourned debate on the motion that Bill 34, *An Act to Amend the Regional Health Authorities Act*, be now read a second time.
