Pursuant to Standing Rule 44(4), Mr. Harrison, Opposition House Leader, gave notice of the intention of the Opposition to consider Opposition Members' Business in the following order on Thursday, May 15, 2008:

- (1) resumption of the adjourned debate on the motion for second reading of Bill 15;
- (2) consideration of Motion 73; and
- (3) second reading of Bill 58.

---

Hon. Mr. Murphy, Government House Leader, announced that following Opposition Members' Business, it was the intention of the government that the House resolve itself into a Committee of Supply to consider the estimates of the Department of Energy, Department of Justice and Consumer Affairs, the Office of the Attorney General, Department of Agriculture and Aquaculture, Department of Public Safety, and the New Brunswick Police Commission.

The Government House Leader advised that on Thursday, May 15, it was the intention of the government that Bill 56 be called for second reading; following which, the House would resolve itself into a Committee of Supply.

The House, according to Order, resolved itself into a Committee of Supply with Mr. Fraser in the chair.

At 12.30 o'clock p.m., the Chairman left the chair, to resume again at 2 o'clock p.m.

And after some time, Ms. Lavoie took the chair as Acting Chairman.

And after some further time, Mr. Fraser resumed the chair.

And after some time, Mr. Speaker resumed the chair, and Mr. Fraser, the Chairman, after requesting that Mr. Speaker revert to Presentations of Committee Reports, reported that the Committee had had under consideration the matters referred to them, had made some progress therein, had passed several items, and asked leave to sit again.

Pursuant to Standing Rule 78.1, Mr. Speaker then put the question on the motion deemed to be before the House, that the report be concurred in, and it was resolved in the affirmative.
