Prayers.

Due to the unavoidable absence of Mr. Speaker, Mr. Fraser, the Deputy Speaker, took the chair as Acting Speaker.

---

Mr. Steeves, Member for Albert, laid upon the table of the House a petition on behalf of residents of the Albert County area in opposition to unjustified cuts in the education system. (Petition 94)

---

Mr. Williams, Member for Kent South, laid upon the table of the House a petition on behalf of residents of the Rivière-Verte area urging the government to reverse its decision to cut the Rivière-Verte government garage to a winter-only operation. (Petition 95)

---

Mr. MacDonald, Member for York North, laid upon the table of the House a petition on behalf of residents of the York North area urging the government to reverse its decision of Government Garage closures. (Petition 96)

---

Mr. Olscamp, Member for Tantramar, laid upon the table of the House a petition on behalf of residents of the Holmesville area urging the government to reverse its decision to cut the Holmesville government garage to a winter-only operation. (Petition 97)

---

Mr. Northrup, Member for Kings East, laid upon the table of the House a petition on behalf of residents of the Petitcodiac area urging the government to reverse its decision to cut the Petitcodiac government garage to a winter-only operation. (Petition 98)

---

Pursuant to Standing Rule 44(4), Mr. D. Graham, Acting Opposition House Leader, gave notice that on Thursday, June 18, 2009, Opposition Members' Business would be considered in the following order: with leave of the House, Bills 85 and 60 would be considered in Committee of the Whole, followed by debate on Motion 67.

Hon. Mr. Murphy, Government House Leader, announced that it was the intention of government that the House resume the adjourned debate on the motion for second reading of Bill 45; following which, the House would consider Bills 59, 57, 28, 48, 26, 45 and 92 in Committee of the Whole.

The following Bills were read a third time:

Bill 75, *New Brunswick Building Code Act*.

Bill 78, *An Act to Amend the Credit Unions Act*.

Bill 79, *An Act to Amend the Securities Act*.

Bill 80, *An Act to Amend the Public Service Labour Relations Act*.

Bill 81, *Condominium Property Act*.

Bill 82, *An Act to Amend the Clean Environment Act*.

Bill 89, *Right to Information and Protection of Privacy Act*.

Ordered that the said Bills do pass.

Debate resumed on the motion for second reading of Bill 45, *An Act to Amend the Real Property Tax Act*.

At 12.30 o'clock p.m., Mr. Fraser, the Deputy Speaker, left the chair to resume again at 2 o'clock p.m.

2 o'clock p.m.

Mr. Fraser, the Deputy Speaker, resumed the chair.

And the debate being ended, and the question being put that Bill 45 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 45, *An Act to Amend the Real Property Tax Act*, was read a second time and ordered referred to the Committee of the Whole House.

It was agreed by unanimous consent that Bill 45 be considered in Committee of the Whole forthwith.

The House resolved itself into a Committee of the Whole with Ms. Robichaud in the chair.

And after some time, Ms. Lavoie, took the chair.

And after some further time, Ms. Robichaud resumed the chair.

And after some time, Mr. Fraser, the Deputy Speaker resumed the chair and Ms. Robichaud, the Chair, after requesting that the Deputy Speaker revert to Presentations of Committee Reports, reported:

That the Committee had directed that she report the following Bills as agreed to:

Bill 45, *An Act to Amend the Real Property Tax Act*.

Bill 48, *An Act to Amend the Tobacco Sales Act*.

Bill 57, *An Act to Amend the Judicature Act*.

Bill 59, *Recording of Evidence Act*.

Bill 92, *An Act to Amend the Gaming Control Act*.

And that the Committee had directed that she report the following Bill as amended:

Bill 28, *Limitation of Actions Act*.

And that the Committee had directed that she report progress on the following Bill:

Bill 26, *Species at Risk Act*.

And the Committee asked leave to make a further report.

Pursuant to Standing Rule 78.1, the Deputy Speaker put the question on the motion deemed to be before the House, that the report be concurred in, and it was resolved in the affirmative.
