Mr. Alward paid tribute to the memory of Mr. Roger (Butch) Wedge, Progressive Conservative Member (Bay du Vin, 1982-1987), recently deceased. Mr. Fraser joined in this regard.

Mr. Paulin, Member for Restigouche-la-Vallée, laid upon the table of the House a petition on behalf of residents of Saint-Jean-Baptiste, Saint-Quentin, Kedgwick and surrounding areas who support the NB Power agreement. (Petition 203)

Mr. C. LeBlanc, Member for Dieppe Centre-Lewisville, laid upon the table of the House a petition on behalf of residents of Fredericton, Yoho, Prince William, Saint Marys, Miramichi, Killarney Road, Tobique First Nations, Dieppe and surrounding areas who oppose the sale of NB Power to Hydro-Québec. (Petition 204)

Mr. Harrison, Member for Hampton-Kings, laid upon the table of the House a petition on behalf of residents of the Coles Island area who oppose the sale of NB Power to Hydro-Québec. (Petition 205)

Mr. C. Landry, Member for Tracadie-Sheila, laid upon the table of the House a petition on behalf of residents of Tracadie-Sheila, Val-Comeau, Val-Doucet, Saumarez, Pointe à Bouleau, Price Settlement, Saint-Pons, Duguayville and surrounding areas who oppose the sale of NB Power to Hydro-Québec and who urge the government to stop all negotiations with Hydro-Québec. That an address be presented to His Honour the Lieutenant-Governor, praying that he cause to be laid upon the table of the House all information in the possession of government including any type of correspondence, e-mails, minutes of meetings, any memorandums(s), phone logs, contracts or personal service contracts however recorded or stored between any government department, agency or employee and Corporate Research Associates Inc. and /or Mr. Don Mills since October 3, 2006.

Hon. Mr. Byrne, Government House Leader, announced that it was the intention of government that the House resolve itself into a Committee of Supply to consider the estimates of the Office of the Premier, Executive Council Office and Department of Intergovernmental Affairs.

And after some time, Mr. Speaker resumed the chair, and Mr. Fraser, the Chair, after requesting that Mr. Speaker revert to Presentations of Committee Reports, reported that the Committee had had under consideration the matters referred to them, had made some progress therein, had passed several items, and asked leave to sit again.

Pursuant to Standing Rule 78.1, Mr. Speaker, then put the question on the motion deemed to be before the House, that the report be concurred in, and it was resolved in the affirmative.
