Hon. Mr. G. Savoie, Government House Leader, announced that it was the intention of government that the House take into consideration Motion 38.

Pursuant to Notice of Motion 38, Mr. Cullins moved, seconded by Mr. Dawson:

THAT, notwithstanding the Standing Rules of the Legislative Assembly, following the adoption of this motion, there shall be 10 hours allocated for the proceedings at all stages of the passage of Bill 17 which shall include the hours spent considering said Bill from December 1, 2023, and onward, and at the expiration of the said 10 hours, unless sooner concluded, the Speaker, or the Chair of the Committee of the Whole House, as the case may be, shall interrupt the proceedings and put every question necessary to dispose of the order for second reading of the said Bill; the order for consideration of the said Bill in committee and report of the Bill to the House; and the order for third reading and passage of the said Bill; and where necessary, the said Bill shall be allowed to advance more than one stage in one day;

THAT, notwithstanding the expiry of the said 10 hours, there shall be, if necessary, 20 minutes allocated at committee stage for the consideration of the said Bill, if requested by the Government House Leader.

And the question being put, a debate ensued.

And after some time, Ms. Anderson-Mason, the Deputy Speaker, took the chair as Acting Speaker.

Mr. Arseneau rose on a point of order and submitted that Hon. Mr. Higgs used unparliamentary language when he used the term "lied". Madam Deputy Speaker ruled the point well taken and reminded Members to not use the term.

And after some time, Mr. Speaker resumed the chair.

And the debate being ended, and the question being put, Motion 38 was resolved in the affirmative on the following recorded division:
